Dear Sirs:

The purpose of this letter is to comply with the requirements of Article 23 of Chapter VII of the Buenos Aires Stock Exchange Rules, in order to inform you that the Board of Directors of the Company, at its meeting held on November 5, 2013, resolved to authorize a new partial modification of the terms and conditions of the acquisition of shares issued by the Company which were approved by the Board of Directors on June 6, 2013 and amended partially by the Board at the meeting held on August 9, 2013 as a means of implementing the Long-Term Compensation Plan in shares to employees. The mentioned approved new partial amendment consists of increasing the maximum price payable for shares of the Company from Ps.160 to Ps.270 on the Buenos Aires Stock Exchange and from \$18 to \$27 on the New York Stock Exchange and extending the term to complete such acquisitions to 90 days starting from the working day following the date of publication of the information in the Daily Bulletin of the Buenos Aires Stock Exchange.

Additionally, at the same meeting, the Board approved the issuance and placement of negotiable obligations for an amount of up to ARS 800,000,000 (eight hundred million Argentine pesos) or its equivalent in other currencies, in one or more series and/or tranches under the Company's USD 5,000,000,000 Global Negotiable Obligations Program, which was approved by the Shareholders' Meeting held on April 30, 2013.
