The purpose of this letter is to comply with the requirements of Article 23 of Chapter VII of the Buenos Aires Stock Exchange Rules.

In that connection, please be advised that during the week of September 09 to September 13, the Company has acquired a total of **2,908** of its ordinary Class D shares in book entry form, Ps.10 (ten pesos) par value per share and each with a right to 1 (one) vote, in the BASE, at an average price of **Ps. 159.50** per share, for a total amount of **Ps. 463,826.00**.

During such week, the Company acquired **69,249** of its American Depositary Shares ("ADS") on the New York Stock Exchange ("NYSE"), at an average price of **\$17.70** per ADS, for a total amount of **\$1,225,777.32**.
