The purpose of this letter is to comply with the requirements of Article 23 of Chapter VII of the Buenos Aires Stock Exchange Regulations.

In that connection, please be advised that during the week of May 16 to May 20, the Company acquired a total of **37,649** of its ordinary Class D shares in book entry form, with a par value of AR\$10 (ten Argentine pesos) per share and each with a right to 1 (one) vote, in the Buenos Aires Stock Exchange ("BASE"), at an average price of **AR\$290.35** per share, for a total amount of **AR\$10,931,349.90**.

During the same week, the Company acquired **60,601** of its American Depositary Shares ("ADS") on the New York Stock Exchange ("NYSE"), at an average price of **US\$20.72** per ADS, for a total amount of **US\$1,255,520.91**.
